WHAT IS FEDARENE

OUR STORY

FEDARENE was created on 8th June 1990 by 6 regional authorities – Rhône-Alpes, Provence-Alpes-Côte-d'Azur, Wallonie, País Vasco, Aquitaine and Nord-Pas-de-Calais (Hauts-de-France). These authorities wanted to make the voice of the regions heard in the debate on energy and environment policies at the European level. The Brussels office opened its doors in November 1991. The six pioneers quickly attracted followers and the network already reached 40 members in 1995.

The successive enlargements of the European Union extended FEDARENE's sphere of influence and today more than 80 organisations from 23 European countries form the FEDARENE network of cooperation. It is now a crossroads for a wide array of agencies which are not only the driving force behind the development of the network, but also play an essential role in policy making. They act as producers of ideas on the regional, national, European and international levels, and as implementers of decisions emanating from these levels.

FEDARENE is one of the founding partners of the Covenant of Mayors for Climate and Energy, which was launched in 2008. The initiative is currently managed by a consortium of networks of local and regional authorities, led by Energy Cities and Climate Alliance, and composed of CEMR, EUROCITIES FEDARENE, and ICLEI Europe. The Covenant of Mayors for Climate & Energy is now the world's largest movement for local climate and energy actions, bringing together over 10,000 signatory local authorities, as well as supporting organisations who strive to fast- track local climate and energy action and go beyond the EU's 40% greenhouse gas-reduction target by 2030.

OUR MISSION



FEDARENE acts as a liaison between local / regional authorities and European institutions. We make the voice of regions and local governments heard at the European level and inform our constituency of relevant European initiatives and policies.



FEDARENE promotes the exchange of experience and the development of transnational projects. Through its events and networking activities, FEDARENE brings together organisations from across Europe to share know-how, develop European projects and replicate successful initiatives.



FEDARENE provides a forum for discussion for stakeholders of the energy sector. FEDARENE serves as a platform not only to its members but to all stakeholders striving for the energy transition: public authorities, non-governmental organisations, citizens, small and medium-sized enterprises and financial institutions amongst others.

WHO CAN JOIN FEDARENE



LOCAL AND REGIONAL ENERGY AGENCIES

- These agencies operate at the local or regional level;
- Their goal is to contribute to the energy transition through the implementation of sustainable energy policies and/or climate and environment measures;
- These agencies are either public institutions created by a public authority to work on its behalf, or private organisations which work closely with local or regional public authorities.

LOCAL AND REGIONAL PUBLIC AUTHORITIES

- These authorities, through their specialised departments, are responsible for the implementation of sustainable energy policies and/or climate and environmental measures;
- In accordance to the statutes of FEDARENE, "region" is construed as "the level of government immediately below that of central government, with political representation guaranteed by the existence of an elected Regional Council or, failing such level of government, by an association or body constituted at regional level by the local authorities at the level immediately below".

The application is voted upon at our yearly General Assembly.

Pay the annual membership fee.

The fee is calculated according to a formula taking into account different elements such as the size of your staff, the GDP and population figures of the said region.
